

### As part of its ongoing efforts to improve the grants administration process, the UAMS offices of Research Administration are initiating a new step in the post-award process

called a "Kickstart Meeting." The purpose of this is to facilitate a more efficient and timely

grant awards account setup. The meeting will be attended by the responsible OSPAN research administrator (RA) and Grants Accounting representative, the Principal Investigator named on the award notification, and the relevant Department or College Business Administrators responsible for primary grants administration support. The meeting will focus on confirming accurate grant award information. Among the key actions will be to: 1) review the awarded budget and discuss any budget revisions that may be required once the awarded budget is loaded into Workday; 2) discuss salary allocations and TBH positions; 3) identify budget items that will result in immediate budget

dates required by the grant; 5) identify any subawards and/or subaccounts that need to be set-up; 6) review match requirements; and 7) any other items necessary to get the project started. This meeting will be held within 15 business days of receiving the award notice. It is intended to improve communication between the Principal Investigator, the department administrator, the OSPAN RA, and the Grants Accounting administrator so that accounts can be set up in a timely manner and expenses collected appropriately on the grant accounts.
